

Fig. 1. Power derating curves SOT223





Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




FR4 PCB; single-sided copper; tin-plated; mounting pad for collector 1 cm²





Fig. 5. DC current gain as a function of collector current; typical values






Fig. 8. Collector-emitter saturation voltage as a function of collector current; typical values




