



### Panel Cut-out for Emergency Stop Push Button (Finished Holes, Ready for Installation)

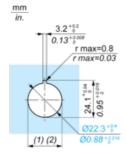
